
A by-law to establish the Fees for Services and Activities for the Township of
Havelock-Belmont-Methuen

WHEREAS Section 391 of the *Municipal Act*, 2001, S.O. 2001, Chapter 25 as amended, authorizes a municipality and a local board to impose fees or charges on persons: (a) for services or activities provided or done by or on behalf of it; (b) for costs payable by it for services or activities provided or done by or on behalf of any other municipality or local board; and (c) for the use of its property including property under its control;


NOW THEREFORE the Council of the Township of Havelock-Belmont-Methuen hereby enacts as follows:

1. That the fees for services and activities for the Corporation of the Township of Havelock-Belmont-Methuen are outlined on Schedule A-Tables 1 and 2, attached hereto and forming part of this by-law.
2. That the fees for services and activities be reviewed on an annual basis.
3. That By-law 2023-087 is repealed in its entirety upon the final passing of this by-law.
4. That this by-law come into force and take effect on the date of passing.

Read a first, second, and third time and finally passed in Open Council this 19th day of March 2024.

NOTES:

Entrance Permits - the property owner is responsible for all costs to install an entrance to their property to the standards required by the Director of Public Works. A deposit is required to: (a) meet a condition of severance if the entrance has not been installed prior to the expiration of the conditions of severance (b) in order to obtain a building permit for an existing lot where an entrance doesn't exist or requires upgrades (c) when the owner has requested a new entrance to the property. The deposit would be returned upon construction of the entrance by the property owner, following the approval by the Director of Public Works. If the entrance is not installed to the satisfaction of the Director of Public Works, the deposit may be used to install a proper entrance.

Staff time - includes current hourly rates, benefits, materials & supplies and any other expenses related to the request.
